The meeting was called to order at 10:07 a.m. with President, David Gale, in the Chair. He welcomed everyone. The observers introduced themselves.

The reading of the Land Acknowledgement by Joy Tanner, George Alevizos and Sandra Beckles was followed by the reading of the Equality Statement by Paul Constable, Amy Matysio, Kate Ziegler, Fiona Highet, Elana Dunkleman, Jameson Kraemer and Dina Pino.

Mr. Gale announced that today, December 3rd, is the International Day of Persons with Disabilities. He said that ACTRA has been a leader in flagging areas that are not accessible.

Mr. Alevizos explained what this means to him and said that it needs to be at the forefront of D&I issues.

"That the Agenda for the ACTRA Toronto Council Meeting of December 3, 2024, as amended, be accepted."

APPROVAL OF MINUTES FROM NOVEMBER 1, 2024

Page 8: Under Financial Discussion – After first sentence add: "Future months of the budget are not looking good."

MOTION #2

Moved by Paul Constable, seconded by Gugun Deep Singh:

"That the Minutes of the November 1, 2024, Council Meeting, as amended, be accepted."

Discussion

John Cleland said that he did not feel that the Minutes reflect the entire meeting.

Gord Rand would like the condition of anonymity be removed from the Minutes.

Paul Constable asked for the inclusion of the sentence "Future months of the budget are not looking good."

A fulsome discussion took place regarding the requirement to attribute statements to Councillors, the reason for taking action Minutes and the need for anonymity.

Joy Tanner said that one of the reasons why we have observers is that they can see how the meetings are held.

DEFEATED (10 in favour, 8 Opposed, 4 Abstentions)

Councillors will send in their corrections to the Recording Secretary no later than Thursday, December 8, 2024. Once received the corrected Minutes will be forwarded by email to the Councillors for approval.

- Length of Meetings Joy Tanner. She said that the Council meetings are very long and they have been getting longer. A suggestion was made that items under Other Business be emailed prior to the meetings.

CHAIR'S UPDATE

Mr. Gale said that since he has been in the process of moving residences, he has not been able to get involved with the committees but he likes what he sees.

IPA UPDATE

Mr. Hepburn reported on where we are with regards to IPA negotiations. We have completed an almost two-week stint in Montreal. Due to a personal need of a lead negotiator on the CMPA's side we had to cut it short. In lieu of this the CMPA offered us two additional meetings. Our AI proposal was not very well received but we remain vigilant with other proposals.

Mr. Hepburn reminded Council that as per the Agenda, he and Gail Haupert would be stepping out at 12:45pm until 2:15pm for IPA negotiations. On Monday, December 9th, we will be going back into negotiations with the full team.

The observers, who are on the IPA Negotiating Team, gave an update. Council gave their whole-hearted support to the Negotiating Team.

A fulsome discussion ensued.

Mr. Hepburn said that going to an expanded bargaining team is amazing and this entire Council is the reason for this!

Mr. Alevizos pointed out that there has been a lot of movement re accessibility. Gugun Deep Singh, with Mr. Alevizos' approval, brought to Council's attention that Mr. Alevizos is not always able to be part of the "base camp". Mr. Alevizos confirmed that he brought to set and never gets the opportunity to mingle with the cast until he is ready to film. He thanked Mr. Hepburn and Ms Haupert for the work that they have put into this.

BUSINESS ARISING FROM NOVEMBER COUNCIL - ED

- Items sent by email following the Council meeting any questions?
 - Los Angeles Update

Marie Kelly, Lesley Brady, Anna Sikorski and Mr. Hepburn went to Los Angeles and exchanged proposals. They were able to field a whole bunch of questions which allowed them to have a conversation amongst themselves. It has been leaked that Carol Lombardini, AMPTP President will be retiring. The CMPA have concerns about the AMPTP producers.

• Prime Time

We will be attending Prime Time in January. Three staff (Luiza Alvarez Restrepo, Taisa Dekker and Gail Haupert), the new President and two Councillors will be attending this event. Councillors are requested to let us know if they are interested. Mr. Hepburn said that it is not cheap to attend but sometimes the work of the union isn't. The approximate cost per person is \$4,000 which includes the \$1,300 cost of the ticket, travel, hotel accommodations for two or nights plus meals.

Doras

ACTRA Toronto has been sponsoring the Doras for the last two years. They approached us with a request for \$5,000 and after a conversation with them, Mr. Hepburn said that they have agreed to \$2,000. This sponsorship comes with two tickets.

• National Council Agenda items

We want to ensure that our voice is heard. It was requested that Council forward any Agenda items to Mr. Hepburn as soon as possible in order for him to forward them to National in a timely manner.

Kate Ziegler said that we can present our best feet forward at the National table if we have some lead time.

Mr. Hepburn said that once we have the Agenda, we can then bring it to this table.

Ms Ziegler said that Council needs to address the information that the D&I Committee is seeking from National.

Website

We are back up and running but not where we want to be. Our small Comms staff would like to build our website. Creator's Corner will be postponed until the first quarter in the new year. We need to do work on generating a survey. Gord Rand and Mr. Hepburn will meet to discuss what needs to be included in the survey. It was agreed that it was a good idea to get feedback ahead of time.

• Awards Update – Paul and Amy

Amy Matysio reported that Yellow House has been working hard on securing venues. The committee will be visiting two venues, one of them being Koerner Hall. They are looking at bringing last year's budget down. The juries will be expanded because of the new awards. Jocelyne Zucco and Pierre Simpson will continue to be jury heads. Agents will now be able to submit their clients. Regarding sponsorships – the committee will be meeting with August Lew within the next two weeks.

• Video Game Update - Elana

Elana Dunkelman gave an in-depth update on the Video Game file. They are hoping that their grant application will bring in \$250,000. They are talking to developers and have let them know that this is a grassroots project. A

survey was sent out with the help of staff to 17 ACTRA Toronto contacts and 13 new or emerging developers. They have attended various events including Toronto Game Expo, Hand Eye Society and Interactive Ontario. Their top issues are: need rates; no buyouts; ACTRA visibility; go international.

Mr. Hepburn said that buyouts do not work for video games as the developers do not have staff to handle the administration. We have to make it easy and simple.

The group will send comprehensive feedback to Taisa Dekker, Gail Haupert, Alistair Hepburn and Elana Dunkelman.

Ms Dunkelman said that she looks forward to making this a Task Force in January.

Mercedes Morris gave a shout out to Ms Dunkelman and her team.

TABLING OF OTHER BUSINESS TO BE INCLUDED PER #7

• Picture Day

Ms Matysio gave a shout out to the folks involved. Krystle Ferdinand, Co-Chair of the D&I Committee reported that it went very well and the Members were very appreciative. 32 Members attended the event.

Tavia Pereira said that the D&I community has reached out to them asking why so many white faces were being congratulated on social media. She said she did not want to denigrate any work that was done by the committee. Ms Ferdinand said that she will let Co-Chair, Roy Urbanozo, speak to this at the next meeting.

- John Cleland said that Bill 149 Jill Andrew's Bill will be discussed at 6pm following a reception at 4pm.
- Kickstarter sponsorship John Cleland

Mr. Cleland reported on the Regent Park Sponsorship. Mr. Hepburn said that ACTRA Toronto has created a school sponsorship with them in the past. That has been our in-kind support. He said that ArtFest has agreed to match any new donation. He said that what they need is cash. Mr. Hepburn said that staff's recommendation is that we donate \$1,000 to help this endeavour.

Ms Tanner asked for a link should Councillors wish to donate privately.

Ms Tova wanted committees to be cognizant that we have a tight budget.

Council was in agreement with staff's recommendation that ACTRA Toronto donate \$1,000.

• PRS 25% fee charged to non-members on residuals – John Cleland

Mr. Cleland raised concerns about the 25% fee that PRS charges to those whose membership has lapsed. He questioned if this was the right thing to do. He said that we should not be punishing our membership if they have fallen on hard times. He asked if we could separate this from the rest of the issues with PRS.

Ms Tova responded that conceptually they have agreed to make an adjustment. National Council would like to deal with the dues but agreed that we need to move this forward. There is a domino effect and we need to know what it is before moving forward.

Heather Allin pointed out that it is not a penalty but a service charge.

• AFBS Ombudsperson – Tim Beresford

Mr. Beresford suggested that we expand the role of the Ombudsperson to AFBS thereby improving the members trust in the AFBS. He asked if it is something that interests Council at large and how best this can be done. He suggested that we float the idea by Ferne Downey and Ron Zammit. Mr. Singh said that he would be happy to serve in that capacity and sit down and have a discussion with Ms Downey and Mr. Zammit.

Mr. Cleland said that this would be another Ombudsperson specific to AFBS. Mr. Rand said that we will be asking if AFBS is in agreement to this role at the AFBS.

Mr. Beresford said he would like to get this started with discussions between Ms Downey, Mr. Zammit, Mr. Hepburn and himself.

Mr. Gale agreed with the suggestion that we find out how many calls the AFBS receives from our members that need an Ombudsperson to get involved in.

- "FAIR" Film and Television Alliance Gord Rand Alistair Hepburn responded that this is a National initiative. Mr. Rand is interested to learn about the eight unions that represent the industry in Canada.
- Update on Conference Committee George Alevizos

Mr. Alevizos said that he would like to start the conversation regarding the Lifetime Awards. Ms Ziegler said that she believed the Conference will be held on February 17th. Mr. Alevizos asked if we are continuing with the Conference Committee, and that he would be in support continuing with the existing conference chairs. Ms Matysio pointed out that this will happen when we have a new ACTRA Toronto President. Ms Matysio said that the original intent was to connect it to IPA bargaining but we are currently on a holding pattern. Mr. Alevizos pointed out that this would give the Committee only a month to plan the conference if we have to wait until the President is elected. Ms Tova said that we can use any event to honour our members. Ms Matysio said that we need to make it clear what we want of the conference or we can hold a reception to hour the Life Members.

Ms Allin informed Council of the attendance at the past Membership Meetings where the quorum was not met and said that the purpose of the conference was to bring the membership "in" and that is where we honoured our members.

WORD FROM SET

- Councillor reported that they did a gig and found out after the fact that there was a problem with their rider which they got after they had already done the work. They wanted to know if this was common to receive it after the job was done. One Councillor said that they got it the day of and never after the job was done. One said that they have had this happen to them but not often. This happens on commercial jobs, but most Councillors said that they did not have it happen under the IPA.
- Elana Dunkelman reported on the 48 Hours Film Festival. 65% had ACTRA Members. She suggested at ACTRA have more of a presence at the festival next year. She said that Roy Urbanozo had an idea of having a fun ad done for this.
 - Mr. Hepburn said that anyone interested should email him as he has complimentary tickets for the December 8th, 2024, Best of Screening & Awards Toronto 48 Hour Film Project.
- It was reported that members have heard some background performers are always late. Mr. Hepburn said that the production is required to let us know and we take action if this is made known to us. Background Casting usually lets us know if this keeps recurring.
 - It was reported that not all background performers get fed, do not have racks to hang their coats, etc., and no seats. It was pointed out that according to the IPA, production does not owe performers food.
 - Ms Ziegler said that when she was recording the podcast some of the background performers did not want to share their experiences. She said that we need to work on background advocacy and we need to eradicate the stigma where background is concerned.
 - Ms Tova said that we need a safe space for these performers. The Background Advocacy position needs to be filled.
 - It was reported that background performers are being cut even though they have not done their job. This is happening quite frequently. A Councillor said that this should not happen if they are in deep background.
- Ms Tanner said that *Performers on Set* pamphlet, when it was published, was distributed by the OSLOs to the performers on set. We can bring that back as an online magazine.
- Ubisoft voiceover on motion capture. A Councillor reported that they were told that another actor was playing their part although they were hired as a motion capture and voice character. They had to only voice over someone else's body. This should be on the table the next time we are in negotiations with Ubisoft.

FINANCIAL DISCUSSION

Treasurer Paul Constable reported. At the moment, we are \$21,856 in the black.

The Committees budgets for next year has been raised by \$500 and Conference budget has been reduced to \$75,000 which somewhat balances things out.

The \$51,397 to be written off is a bad debt.

At the January Council meeting the staff-drafted budget will be presented to Council.

Mr. Constable presented the following revised recommendations on behalf of the Financial Stability Task Force:

- 1. increased communication and transparency from National to members. A reconsideration of the request to remove NDAs is recommended.
- 2. Working dues must be part of the discussion.
- 3. A breakdown of austerity measures to decrease spending from National.
- 4. A breakdown of the impact to AFBS on a "one and done" joining change.
- 5. Treasurers from every branch to sit on the financial stability task force.
- 6. A communication strategy on how this would be potentially rolled out to members and data regarding our social media and email uptake.

After a fulsome discussion the following was agreed upon:

Dues Discussion Points

- 1. Working dues will be considered and discussed. Agreed to
- 2. A promised discussion to explore a decrease of spending across all branches. Hold until January
- 3. A breakdown of the impact to ACTRA and AFBS on a "one and done" joining change. Hold until January
- 4. Treasurers from every branch to sit on the financial stability task force. Agreed to branch observer
- 5. An increased and transparent communication strategy, including how a dues increase would potentially be rolled out to members and data regarding our social media and email uptake. *Agreed to*

ACTRA Toronto Dues recommendation

- Basic dues to \$250 over the recommended timeframe
- Working dues to 2.50% in year 2
- Dues cap at \$10,000

MOTION #3

Moved by Heather Allin, seconded by Tavia Pereira:

Whereas this Council authorized that RCAP Councillors may hold meetings with RCAP ACTRA members outside of Council with the understanding that their agendas would be shared;

And Whereas the whole of this Council has the responsibility to be informed as to all members concerns;

And Whereas it would benefit this table to have the transparency of such concerns being brought to the table where Councillors are made aware of the content and positions expressed at these meetings;

Therefore, Be It Resolved That the RCAP representatives on this Council provide the agenda in advance and a fulsome report of Councillors' work with these non-members of council from every RCAP meeting;

And Further, that they also bring forward the concerns and decisions arising, from each and every meeting, to this Council, at each Council meeting.

Discussion

Mr. Singh said that people are supposed to report these meetings. Mr. Hepburn confirmed that Mr. Beresford has been sending the Agendas to him in advance of the meetings. Ms Allin said that, if so, then this Motion is redundant. Mr. Beresford apologized for forgetting to forward notice of the September meeting to Mr. Hepburn, but he did forward him the Agenda after he was reminded.

There was some discussion if this Motion is about requesting Minutes, Ms Allin confirmed that this is not about requesting Minutes but notice of meetings and Agendas in advance of the meetings. She was also requesting fulsome reports from the RCAP meetings.

The question was called.

And Whereas, we need to have Anti-Black Racism Training; And Whereas, we also need Ableism Training.

Discussion

Ms Tova said that governance is not usually followed here and it might be a great place to do some review.

Ms Tanner reminded Council that it took them five months to get the Operating Plan up and running. She said Committee Chairs have said that they will not work with their Liaisons.

Ms Tova said that there are attempts by this Council to take on staff work.

"Whereas the current ACTRA Toronto Council has encountered difficulties in finding paths forward that reach respectful consensus, and whereas many Committees have experienced concerns with their Executive Liaisons;

And Whereas, mediation and training will support this Council into functionality;

Therefore, Be It Resolved, that this Council, including those with voice and no vote and the Chairs of all Committees and Caucuses take Governance and Anti-Misogyny Training;

And, this Council will agree to engage in Facilitated Mediation;

And, this Council commit to have Anti-Black Racism Training;

And, this Council also commit to Anti-Ableism Training;

Mediation and training will commence no later than 60 days upon the passing of this Motion. Council will also invite ACTRA Toronto staff to take part in this training as applicable."

- Attended Buffer Festival's Digital First Canada conference on November 1st, 2024.
- A group of members created a video game task force with the goal of connecting with indie game developers to encourage them to go union. They wrote a survey for game developers, and Ms Dekker reached out to 17 signatory engagers that produced video games with members from 2016 onward to procure feedback.
 - o In November, she met with 5 signatory video game developers to go through the survey questions and discuss their experiences working with union talent.
 - Meetings with 2 developers scheduled for December.
- Attended the <u>Toronto Game Expo</u> on Saturday November 16th to speak with video game developers. Five members of the video game task force also attended.
- Reached out to Toronto Game Expo organizers to inquire about having a booth at the next expo, taking place March 29th and 30th, 2025.
- Attended Ontario Creates & Canada Media Fund <u>Futures Forward</u> program webinar, which outlined the application process for video game companies eligible for this funding.
- The Hand Eye Society's SuperFestival took place November 25th to December 1st, and ACTRA Toronto <u>promoted</u> this free video game event to members. and provided a few items of swag for HES door prizes to increase awareness about the union to indie game developers.
- Attended a networking event hosted by WIFT-T.
- Negotiated a sponsorship agreement with TAAFI for their industry conference in April 2025.
- ACTRA Toronto is sponsoring an event hosted by the Theatrical Arts Education Association on December 9th to promote union membership to secondary students.
- A concerned member reached out about Telefilm supporting non-union productions, which coincided with outreach to the funder from the National office. ACTRA, along with other unions and guilds, sent a letter to Telefilm on November 12th urging them to stop financing productions that refuse to sign collective agreements, or fail to abide by minimum standards. - Attended a meeting with the SPF Climate Action working group.

- Attended the OGS Advisory Committee meeting where member organizations heard progress on ongoing goals and tactics within the <u>Strategic Plan</u>. Highlights include:
 - o In May, the new Carbon Calculation Fundamentals course became available with 11 sessions taking place so far, and the newly revised Sustainable Film Productions Fundamentals course will be introduced soon.
 - o OGS hosted the second electric generator workshop in November.
 - o There are now over 90 locations on the OGS grid tie-in map.
 - o Almost 3,000 meals donated through Second Harvest up to the end of August 2024.
 - OGS presented at the Sustainable Production Forum.
 - o Launch of the Waste Signage kits, and distribution of the kits to studios.
