**Page 5:** Under Business Arising from November Council. 6<sup>th</sup> bullet point – Awards Update. 3<sup>rd</sup> sentences should read: ~~They are looking to slash last year’s budget in half.~~ **“They are looking a bringing last year’s budget down.”**

**Page 9:** Under 2<sup>nd</sup> paragraph under Discussion – Add: **“She was also requesting fulsome reports from the RCAP meetings”.**

**TABLING OF OTHER BUSINESS TO BE INCLUDED PER #10**

There were no items tabled.

**CHAIR’S UPDATE**

Mr. Gale noted that choosing the next ACTRA Toronto President should not be taken lightly. He said that “we need to elect someone who is as loving and as kind as possible.” Nobody was expecting to be in the work environment as we are now.

**PRESIDENTIAL ELECTION**

Heather Allin said that she heard that there is an alleged “grievance” against one of the candidates who is planning on running for President. She wanted to know what would happen if that candidate is elected and in the event that these grievances are found to be true.

Alistair Hepburn pointed out that there isn’t a grievance process under our By-Laws. Grievances are under the contracts under the ACTRA Agreements. He believed Ms. Allin meant to use the term “complaint”.

John Cleland pointed out that any allegations not proven and that the precedent it would set is pretty dangerous.

Mr. Gale noted that any complaints would have to be substantiated.

Gord Rand said that this comes as a bit of a surprise and asked why this was not brought up in earlier months. He said that this issue would be confidential. He agreed with Mr. Cleland that it is an unproven allegation. It can be weaponized against anyone and sets a precedent.

Mr. Hepburn said that no names have been mentioned, and that any alleged process is well underway. Council are still at the point where we have not crossed that bridge and recommended that Council not cross that bridge.

David Wallen said that he did not think that Council should convict anyone without a process.

Joy Tanner said that this is a troubling allegation brought to the table.

Mr. Wallen said that Mr. Hepburn has made a good point – under the By-Laws we have a process in place and Council needs to move forward.

Mr. Hepburn was given the chair for the final time by outgoing President Gale. Council gave outgoing President, David Gale, a standing ovation and thanked him for his services.

Council decided that should an Executive member be elected as President; Council will wait until the February meeting to fill this position. This will be Councillors a chance to decide if they would like to run for the vacant position.

Ms Smallwood appointed Ana Sani as Scrutineer and Ms Ziegler appointed Emily Hurson as Scrutineer. The Scrutineers joined Mr. Hepburn and staff scrutineers Gail Hauptert and Freda Merritt-Gambrill when the ballots were counted.

The floor was open to questions. Many questions were asked and answered.

The ballots were cast and a second round of voting was required because of tied ballots.

A second round of ballots were cast. The scrutineers reported that they witnessed a fair and accurate count.

### **MOTION #3**

Newly elected President Kate Ziegler assumed the Chair at 1:15pm.

Ms Ziegler acknowledged Ms Smallwood and said that she hopes “to heal any vibrations”. She thanked Mr. Gale for his levity and humour and calm leadership. She said that she was “proud and thankful and knows that Council will figure it out together.”

### **OP PLAN 2024 REPORT CARD DISCUSSION**

Mr. Hepburn walked Council through the Report Card.

Referring to the training items, Ms Tanner said that a lot of the items are interconnected and asked if we have resources so that we can look into them. Mr. Hepburn said that we need the actual training module before we can do anything.

Asante Tracey said that he would like to help with this.

Regarding bargaining, it was suggested that a Negotiating Strategy Committee be established. John Cleland asked if this could be raised at the Town Hall to see if the membership is interested. Mr. Hepburn suggested that we not talk about this until we are ready to see what that committee is about. Paul Constable, Cory Doran, Ana Sani, Geoff Scovell, Gord Rand, Heather Allin, Angelica Alejandro, Tonjha Richardson, Amy Matysio, John Cleland and Tova would like to be included in these discussions.

Elana Dunkelman recommended Council set up an ACTRA Toronto Minors Committee.

AFBS Conversation re benefits – Council would like to start on this file this month and would like to have the following conversations with AFBS – Cap year; Disability Alliance letter and Ombudsperson position.

Regarding the Op Plan it was noted that overall we have accomplished 50%. Mr. Hepburn will send out a revised document to Council. At the next meeting there will be a Blue Sky to discuss what Council would like to accomplish during the next fiscal year.

## **OTHER BUSINESS**

There was no other business.

## **BUSINESS ARISING FROM DECEMBER COUNCIL – ED**

### **I. Gord – Motion Four Unions Festival**

Mr. Rand said that this will probably include other unions. He was seeking permission from Council to start communications with staff of other unions. It was noted that this would have to go through Mr. Hepburn and the President. Mr. Tracey would love to have the support to go further with this.

Mr. Alevizos asked how much this would cost. Mr. Rand said that he hoped that everything would be donated, including the space. They would like this to be free and fun as possible without violating labour rules. This is no plan to ask for money. He would like to discuss this with our sibling unions. Mr. Tracey suggested looking further into it and have a Creator's Corner meeting that is more focused. They would then come back to Council with suggestions in February or March.

### **II. Gord – Motion Accent Discrimination Info Video**

There are questions that need to be answered on how this will be delivered. He is looking for feedback on how to proceed with it. He said that this might have to be done through the Executive. Mr. Hepburn said that we want to ensure that whatever is being produced, that the ownership stays with us.

Ms Allin cautioned that they should have all their ducks in a row before they move forward. She will talk Mr. Tracey and his team. Tavia Pereira felt that this should be submitted to the Executive.

### **III. Paul – Letter from National Council**

Mr. Constable said that at the next National Council meeting he would like two hours set aside to discuss issues in a respectful and frank manner. He asked Council if they would be comfortable with him taking the lead and drafting a letter. Nicola Correia-Damude has a couple of thoughts on this and suggested that Toronto Council have a Zoom call to discuss it.

Ms Ziegler said that this a confidential issue which should not be discussed with observers present.

### **IV. ED – Facilitated Mediation**

Mr. Hepburn reported that he has been in contact with several companies who offer this service. He will email a package to Council for their input. Amy Matysio cautioned that we should be very careful with the choice we make.

## **WORD FROM SET**

- Ms Morris said that during the postal strike she was told that cheques were being put in the mail. Ms Ziegler said that she contacted Mr. Hepburn and this was corrected immediately. Ms Tanner suggested that Members should call their agents and have their cheques reissued. Gail Hauptert clarified what happened with the cheques and the procedures that were put in place.
- Mr. Cleland said that he will bring the Green Screen information to the next Council meeting.
- Regarding an Unfair Engager – Ms Ziegler asked if this was vetted through the union. She said that it feels like our Members do not know how to vet a project. Ms Hauptert responded that ACTRA Toronto reached out to the producer and gave them a warning that they cannot produce until they clear all outstanding payments on other

productions. Ms Ziegler asked what steps are taken if a production is not reputable any longer. Mr. Hepburn said that Members should refer to the Unfair Engager list that is on the website.

Alana Bridgewater said that it is not just an ACTRA problem, it is a real concern with DGC, etc.

Jameson Kraemer suggested that a letter be sent to the agents to remind them of the Unfair Engager list.

Mr. Hepburn said that putting a link on the first page of our website is easy. He informed Council that *Whistle* is now off the Unfair Engager list.

Ms Tanner suggested bringing this conversation as a side bar with the committee might be helpful.

#### **COMMITTEE & CAUCUS UPDATES AND REQUESTS NOT IN THE WRITTEN REPORTS**

- *YEAA*: Tavia Pereira announced that she is stepping down as the Co-Chair of YEAA and is leaving it in the hands of Ms Morris. Ms Ziegler thanked Ms Pereira for her work on the YEAA Committee. Ms Morris said that the Committee will talk about a replacement at their next meeting. She thanked everyone who supported their holiday initiative.
- *Awards*: Ms Matysio reported that the Committee held a sponsorship meeting. They are going ahead with Koerner Hall as the venue.
- *AYA*: Ms Ziegler announced that the AYA Co-Chairs are stepping down in February. They have been struggling to get Members to come out to their events. They have some ideas who they would like to approach. If Councillors know of anyone who would be interested, Ms Ziegler asked that they should let her know. Ms Brooks said that there might be Members of the Apprentice Caucus who might be interested in this.

#### **AWARD OF EXCELLENCE – IN-CAMERA**

At this stage, they are asking Councillors and fellow committees to help spread the word about the toy drive and, if possible, make a donation by dropping off toys at the ACTRA Toronto office. They are already excited to receive some offers of donations!

They will be opening a volunteer sign-up list soon and will provide an update to the Executive and Council after their subcommittee meeting on November 27<sup>th</sup>, where they will finalize Phase 2 of the initiative.

- Work continues connecting with indie game developers who have previously engaged union performers on video game productions about their experiences working with the union.
- ACTRA Toronto sponsored the Theatrical Arts Education Association’s Star Fest at York University on December 9<sup>th</sup>.
