Apprentice Caucus - Chair, Victoria Brooks

The Apprentice Caucus met December 11th for 90 minutes at ACTRA Toronto offices.

- Continued questions about shuttles to get to early BG bookings. Reiterated to ask agents for as much information as possible on accepting in order to make an informed decision as to whether they can reasonably accept the job.
- A member suggested a template of information that is shared with talent via BG casting, that is then shared with BG agents, and then shared with talent.
- Continued discussion on what went wrong with the Compass Artist Management, and how to learn from the situation. How to protect themselves going forward.

Act Your Age (AYA) – Co-Chairs, Heather Dick and Ann Wootten

- On December 13th, AYA set up a virtual meet-up to chat and catch up as the year draws to a close. Despite the busy holiday season, 11 members joined and shared their news, offered suggestions for 2024 workshops and wished each other merry holidays. Another 7 members sent regrets. Thank you to ACTRA for the Zoom link and to Karl and Luc for their assistance on the day.
- At the holiday meet-up, they had a chance to thank Jocelyne Zucco, their out-going Toronto Council liaison, for her support and assistance over the past couple of years. She has always championed their cause and was a great help as Anne and Heather took over as Co-Chairs last January. They are sad to lose her as their liaison but wish her well going forward.
- At the meet-up, AYA also updated everyone on the planned ClipChamp workshop to be organized and run next February in partnership with CAN (Canadian Artist Network). Their members are very interested in this workshop and unanimously agreed that, while they are getting more comfortable with actually recording self-tape auditions, they don't feel competent with editing programs and welcome the chance to take their audition tapes to the next level. CAN will run the workshop and pay for the instructor as they feel that it will benefit all artists who need to document and submit videos of their work and art for applications of all kinds. The Co-Chairs will reach out to CAN at the top of the New Year to start the organizational wheels in motion.

Past President's Report - Theresa Tova

They continue to problem solve issues with coaches, agents and actors through two main files.

AACE

As part of her Past President files, Ms Tova co-administers the <u>Association of Acting Coaches and Educators</u> with Jennifer Wigmore. They have built a community of 110 coaches who are fully vetted AACE members with over 60 applications in the membership pipeline. The industry partners and community supporters include ACTRA, CAEA, TAMAC, the EIC, Equity Showcase, The CDC, TAPA, AFBS and more. Their day-to-day work consists of providing ongoing education to coaches on respect-based practices, industry standard business practices and mediating complaints.

AACE presented two educational workshops in November: **Resiliency** with Actor Care specialist Alan Powell and **Power Dynamics** with Niki Landau. Power Dynamics was created with the support of ACTRA Toronto staff and will soon be available online. Both offerings were well attended. They also streamed **Creating Brave Spaces**, a free online panel discussion on December 1st. The practitioners from Montreal, Toronto, Arizona and the UK explored specific techniques on how to provide consent-based practices and agency for their students. The panel discussion is available on our AACE YouTube channel.

Agents

Ms Tove missed the monthly Agents/ACTRA meeting because of work.

The Entertainment Industry Coalition

On December 11th I chaired a community meeting of 50 TAMAC and EIC agents over Zoom. They were joined by ACTRA Toronto Executive Director, Alistair Hepburn. They started discussions on a number of industry-related issues. Volunteers came forward for a committee to look at proposal language that will be brought back to the larger group. There are many different ideas floated but what they all agree on is the need ensure both actors and agents are protected.

TAWC – Co-Chairs, Heather Allin and Tonjha Richardson

TAWC seeks to extend their committee membership renewing existing ones and creating new committee members, by reaching out to their contacts and telling them about the work they are doing. Their last meeting has generated some interest and they hope for more as they start to have regular meetings and a program to accomplish.

As committee reaffirmed their intention to restart the TAWC Tool-Kit (a juried short film with mentorship and production sponsorship) launching summer/fall 2024 and the Nell Shipman Awards (for a woman or gender non-conforming individual who has done exceptional work to open the space for women and non-binary artists, particularly performers), launching spring 2025; they are seeking folks to help with either or both of these projects.

TAWC is considering who to invite as the guest speaker for January.

They are holding calendar space on January 25th, 1:30-3:00 for their next meeting.

They continue to pursue a dedicated ROS (Respect on Set) workshop for TAWC and other committee/Council members. A minimum of 20 is desirable.

*We recognize the terms "Woman" and "Women" (Female/Male/Man/Men) are gender constructs and we seek to create a safer space for all gender members who are interested in furthering the mandate of the committee. We are aware of the constantly evolving nature of language and the need to be conscious of language that may be micro aggressive, racist, sexist and exclusionary, and seek to self-educate towards best practices. We also recognize that neither equity nor parity is yet achieved in this society or the world at large and seek to further that vision.

We acknowledge that we live, work and create on the unceded and traditional lands of the Ho-de-no-sau-nee-ga (Haudenosaunee), Anishinabewaki くっている Mississaugas of the Credit First Nation, Mississauga, and Wendake-Nionwentsio territories. We recognize that we are all Treaty people and seek to work toward redressing the injustices from which Settlers of this land have benefited.

- They are in talks with Gail Haupert now to create an IPA survey AND a separate meeting (outside of their usual committee meeting) with members of the Voice Committee who work under the IPA to address any concerns. They want to compile a list of asks and needs (potentially in order of priority) that they can give to the IPA negotiating committee.
- The Voice Committee also wants to advocate for one or two voice performers to be on the bargaining team.

- Social/Social Media Subcommittee will be meeting January 18th from 2-3 pm and 3-4 pm respectively.
- Newsletter to be released TBA. It's been a pleasure to serve as Liaison for this rebooted Committee and see it flourish under the leadership of Chair Tavia Pereira and the active individuals of the committee. It is Ms Tanner's hope that the new liaison will encourage and support this group fully going forward. They have a lot to offer energy and bright initiatives. She can't wait to see what they do!

Council broke for a half-hour lunch and resumed at 3:45pm. The National Update was moved to after the lunch break. It was suggested that the blue-sky session, Item 9, Operating Plan – in themes, be moved to another meeting.

NATIONAL UPDATE

Marie Kelly reported. She congratulated everyone who was elected for the first time or re-elected to National Council. She also congratulated those Councillors who were elected to the ACTRA Toronto Executive committee. Ms Kelly advised the National Councillors to read the kits that will be emailed to them prior to the February 9th National Council meeting. The meeting will be held at a hotel/conference centre.

UBCP will start negotiating the BCMPA three months after us. She said that we need to do things differently this time. It would be nice to do a National survey instead of each branch sending out their own surveys. We need to find ways to find resources for the many fights for both the IPA and NCA. We fought hard at the last negotiations for the hair and makeup grievance.

Ms Kelly noted that many members are too afraid to fight for their rights – how do we crack that nut.

The National DEIB committee is working on a panel and workshop regarding the hair and makeup issues. We have five bargaining days set aside for DEIB issues with the CMPA.

Ms Kelly said that she would like to have ACTRA's proposals ready by June well in advance for bargaining. We are looking at November dates.

Organizing and Lobbying – the Council of Unions talks are moving slowly. We are trying to find new ways to organize the commercial sector. Ms Kelly said that we must become an organizing union. It is a lot of work and a lot of resources are needed. We have to set up a committee to do it and we need resources.

Ms Kelly said that we almost lost the Status of the Artist legislation but we are pushing back. What should Cancon productions look like in this new world?

We are talking to the government about AI and copyright. We do not have copyright protection for actors but we do have it for musicians. We are spending a great deal of time educating our government.

A discussion ensued regarding organizing the commercial production agencies.

EXECUTIVE DIRECTOR'S UPDATE

Alistair Hepburn reported.

HAVEN Hotline: The HAVEN 24-hours hotline service we currently have is coming to an end at the end of February and ACTRA Toronto will not be renewing the contract. We will not be receiving funding from Telefilm. The cost per incident report was more than \$3,000 which is not a good return on investment. We will, in the interim, move to the MAP. Although the MAP (Members Assistance Program) is only available to Full Members, we have a guarantee from AFBS that anyone who calls into that number regarding an ACTRA related incident will not be turned away. The call-in number will not change and the call will be directed to MAP. ACTRA Toronto will not get a report from AFBS and the Member will have to call ACTRA Toronto to report the incident and we will then follow up with the Member.

Awards: Mr. Hepburn said that we can max out the invite list to 500 individuals. A maximum of 50 per cent can be a lottery for members. The cost will be \$100 per non-refundable ticket for members and \$250 for

industry guests. Cass Enright said that live-streaming adds a significant amount the cost of the event hence it would not be possible to live-stream.

Industry Initiative & Outreach - Taisa Dekker, Manager

- Presented to fifteen students in the Theatre Arts performance program at George Brown College on December 15, 2023, with Janet Rose Nguyen.
- Met with an instructor of production management courses for both a college and industry association about engaging ACTRA performers and the specifics of use fees.
- Spoke with a production team working on an interactive digital media prototype project about contracting union performers.
- Connected with a producer I met at the Blood in the Snow Development Lab about engaging minors on an upcoming feature film going to camera in early 2024.
- Throughout 2023, I presented to 563 film production students in 10 post-secondary programs about how to engage professional performers on various types of productions.
- In 2023, I presented to 312 performance students in 12 post-secondary acting programs about the benefits of joining ACTRA.

WORD FROM SET

- A Councillor suggested that there should always be a BIPOC representative on the Executive. Mr. Hepburn informed Council that this will require a change to the ACTRA Toronto By-Laws and will require a referendum.
- Issues with Casting Directors was raised and Councillors asked if there was anything in place like AACE where
 these issues can be discussed. Mr. Hepburn said that we do not have any jurisdiction over Casting Directors
 and do not have the ability to censor a Casting Director. Luisa Alvarez-Restrepo and Jenn Paul are the staff
 members that Members need to contact. They will do the intake on the call. More work to be done on this
 file.

The Recording Secretary left the meeting at 5:10pm.
