 - Permit Access Fund update. Warners contributed 50% of qualifying permit fees/ This initiative was the result of work by DEIB Manager Luisa Alvarez Restrepo at Banff.
 - Ontario Green Screen 24/25. Looking to help energize the work.
 - AACE update. ACTRA Montreal is a new industry partner. ACTRA Alberta is in conversation and so is ACTRA
 Ottawa. Exec was positive about the work and growth of AACE. Exec wants to bring this to council and
 recommends we recommit as Steering members and industry partners. See our statement of support.

BUSINESS ARISING FROM APRIL COUNCIL - ED

Alistair Hepburn report.

Staff at Council

This portion of the Executive Director's report was in-camera. The observers and the Recording Secretary left the meeting during the in-camera session.

- o Update on GNC/M category award
 - Janet-Rose Nguyen reported that the conversation regarding the awards has not taken place yet.
- o Creator Corner Gord Rand

Mr. Rand's alternate reported on his behalf. He has received a lot of great responses and people are anxious to get talking. He wants to save publicizing until after the May 13th rally and is preparing an email to be sent out about the Zoom Town Hall. He will coordinate with Mr. Hepburn on this. The date of Wednesday, June 19th is being proposed to get a good month of prep for it. A link to the present Low Budget Production options available from ACTRA will be included so that they all can speak concretely about what is already included.

Other than that, the Town Hall will be structured loosely to keep the conversation open and flowing, with the idea that the second half will be more of a brainstorming session of what creators are hoping to happen rather than focusing on what might be improved. Mr. Rand would be happy to chair this session. He also would like this to be minuted and is not sure whether it needs to be staff or a volunteer.

Regarding an Executive Liaison, Mr. Rand understand that this decision will have to be made by the Executive but he feels that Amy Matysio would be great as she is a producer/writer/actor and all around multi hyphenate and has expressed willingness to help him out.

o LA Report

Mr. Hepburn reported that whilst in LA on the Mayor's Mission to promote Toronto, they met with studios including Netflix, Disney, Focus Features, Universal, Amblin Entertainment, DreamWorks and Sony. Due the potential IATSE strike and the political climate in Atlanta, studios are looking to film elsewhere. Marvel expressed concerns about the diversity in Toronto. The studios are aware that we have ample studio space. Cynthia Lynch, Managing Director and Counsel of FilmOntario, who was part of the delegation that went to LA, explained to them how the tax credit works.

A Councillor requested that a census be done to support the data re diversity in our membership.

A Councillor requested that ACTRA raise the question with the government regarding Americans coming here to work under the Temporary Foreign Worker Program. Marie Kelly said that there are a lot of different ways to approach this. Mr. Hepburn said that the Temporary Member Clause in the ACTRA By-Laws has been updated and this opens the door for more performers to take ACTRA membership if it is a long shoot.

o Life Member

This discussion was held in-camera. Council voted on which two Toronto Members would receive Life Membership. This will be made official once the member(s) accept this honour. Three individuals were chosen.

It was felt that having accountability is important. The Chair said that the Executive figure out how to operationalize it. The Executive Director suggested that the role of secretary be shared among the Executive. It was also suggested that the minutes be approved by the Executive prior to being distributed to Council.

Fulsome discussion took place as to whether this role be fulfilled by the Executive members in rotation, a Councillor or staff. The Executive felt that the minutes should be recorded by a neutral source, i.e. the Recording Secretary.

IPA BARGAINING TEAM DISCUSSION

The Executive Director withdrew comments made at the last Council meeting regarding the Stunt Community vote. Shack Shackleton thanked him and said that he looked forward to moving ahead.

Mr. Hepburn reported that Kwaku Ado-Poku and Amy Matysio have withdrawn for the Negotiating Team as they have other commitments.

A fulsome discussion ensued. Council felt that Amy Matysio would be an asset and that they would like her to be involved in bargaining. Council agreed to Ana Sani being Mr. Adu-Poku's replacement and Cory Doran as an alternate.

"That Council approve the appointment of Ana Sani as the primary member to replace Kwaku Adu-Poku and Cory Doran as an alternate on the IPA Bargaining Team."

- Event planners be part of the organizing committee.
- Going back a seated event.

Mr. Hepburn said that the venue was booked for a different type of awards and when we pivoted, we were locked into the venue.

It was felt that it would be helpful if the delegates met with Taisa Dekker prior to the event. A fulsome discussion ensued as to who would be part of the ACTRA Toronto delegate to attend the summit. Council nominated a number of members and it was suggested that an online poll with be conducted.

UPDATE FROM NATIONAL COUNCIL

National Executive Director, Marie Kelly, reported.

IPA bargaining – Staff are putting together the proposals.

Re Dubbing – at the last round of negotiations it was agreed that the parties would meet about dubbing. The ACTRA Bargaining Team went to Montreal for a two-day bargaining session which did not happen. This section has not been addressed in a long time and the other side had agreed to meet, however, they did not have their Chief Negotiator present. Proposals were exchanged. ACTRA has said that we will meet over Zoom when they are ready.

Pre-bargaining for Hair and Make Up – we had one day of bargaining and have four more days to go.

Frank (Francois) Desjardins is working on putting together an educational proponent for non-union performers.

Re Intimacy Coordinators – ACTRA made an application in Quebec under the IPA and this has been approved. We have notified the APQM of our intention to bargain.

OLRB – A member gave great evidence and we now have additional dates.

Met with the National Council met on May 14th to notify them we have a tentative agreement on the NCA with the ACA. A referendum will be going out on May 28th after the May 27th webinar to inform members of the terms of the agreement. The return date of the referendum is June 12th.

A Councillor proposed that ACTRA Toronto line up webinar dates after the National webinar.

Ms Kelly said that she was sad that she couldn't attend the We Rise Up rally. It was not good timing.

AACE STATEMENT OF COMMITMENT*

*AACE – Industry Partner Statement of Support

As industry partners of the Association of Acting Coaches and Educators (AACE), we are in full support of the AACE code of conduct, guidelines, and ongoing respect-based education that will bring much-needed oversight, best practices, accountability, and standards to the sector. We encourage all educators to apply for AACE membership as we are committed to promoting and working with AACE-recognized Coaches and Educators in the future.

The Chair reported that AACE was created after the MeToo as it was felt that this area needed to be organized. AACE now has 122 members and it had the support of the last Council. She said that AACE would like support from this Council as well.

NCA TASK FORCE REPORT

Kate Ziegler gave a brief report on the rally. A fulsome report and debrief is forthcoming. She thanked everyone for their support.

DUES DISCUSSION

Mr. Hepburn informed Council that \$47.50 is transferred to ACTRA National for every member ACTRA Toronto gains, alongside their yearly dues. We need to find another way to fund the branch. He pointed out that member working dues have a yearly cap. Further discussion on this needs to take place.

WORD FROM SET

AABP member issues are stirring up again. A meeting has been scheduled for Friday.

An OSLO reported that members are feeling that they are being stereotyped.

The OFL is open to having dialogues with our members who are facing these issues. MPP Jill Andrew has said that they will help navigate a dialogue.

The Chair said that she will get help from DEIB Manager, Luisa Alvarez Restrepo to help facilitate a dialogue.

Kate Ziegler, Stunt Committee Liaison, said that the Stunt Committee is busy with work commitments. They are talking about how they can better communicate with our Members.

Act Your Age (AYA) – Co-Chairs, Heather Dick and Ann Wootten

From their past brainstorming sessions came requests for practical self-taping, as well as acting scene audition workshops.

In March the Committee organized an online self-taping session with ACTRA member, Trish Adams to discuss and demonstrate how to use the Clipchamp app. It is a free app that is useful for editing self-taped auditions. Attendance was good and there was great feedback for Ms Adams as an instructor, and the Clipchamp app has proven to be helpful in creating more professional looking submissions. She kindly edited the recorded Zoom session down to a 12 minute 'how to' video that they will post shortly on the AYA website page for all their members to access going forward.

In April AYA held a hybrid in-person and Zoom workshop with ACTRA member, director and acting coach, Marianne MacIsaac called KISS: *The Callback Audition Workshop*. Ms MacIsaac took nine readers through two-person scenes as if they were coming for in-person callback auditions after successful self-tape submissions. The focus was on connecting & creating the chemistry with a partner that would get them the booking.

The Co-Chairs are sending a big thank you to Karl Pruner, Luca De Franco, and Freda Merritt-Gambrill for helping them promote, set up, and strike the equipment in the boardroom. There were nine in-person participants, three in

the room observers, and five online observers from as far away as Vancouver. Everyone in the boardroom was delighted to be gathering together again in person.

Anne Wootten and Heather Dick are meeting soon to discuss further events for the AYA Committee.

Child Advocate – Angelica Alejandro, Child Advocate

- On Wednesday March 27th, Clare Johnston (Child Advocate Staff Liaison) and Angelica Alejandro co-hosted a Parents/Guardians Zoom meeting. they were pleased to see a great turnout of parents/guardians. Since the Protecting Childs Performers Act (PCPA) applies to all minor performers, this Zoom meeting was attended by parents/guardians of both Union and Non-Union minors. They were lucky to be joined by guest speakers Officer Megan McGarry (Toronto Police Service) and Agents who represent minors Jackie Warden (Ritter Talent Agency) and Yanick Landry (Newton Landry Management Inc.). Parents/guardians came together to discuss minors working in the industry. This included everything from the PCPA to the IPA and how minors are engaged for work, with time spent on concerns, issues and responding to questions. It was a great opportunity for parents to speak on the challenges and issues facing minors working under the IPA agreement.
- As the Zoom was not recorded, in the weeks that followed Ms Alejandro continued to have many one-on-one meetings with parents who were unable to attend. They had forwarded their questions ahead of time and these were discussed in the Zoom. These meetings were to circle back to them for a post-Zoom debrief.
- Communications this month to the Advocate Office have been about those new to the industry wanting information about ACTRA, inquiries about agents, tutoring, stunts and issues on set.
- Up Next: Facilitate for Minors and their Parents/Guardians: ROS for Minors 15-17 with information on Minors Trust and Insurance. ACTRA Toronto Committee similar to the UCBCP/ACTRA Guardians of Minors Committee (Ms Alejandro had outlined this in more detail in the prior report to Council) In talking with parents to helping them define what they want in a committee, there are other suggestions and quick wins which I will bring forth to Executive and our Staff Liaison Clare Johnston.

Diversity and Inclusion Committee – Co-Chairs, Krystle Ferdinand, Dorly Jean-Louis and Roy Urbanozo

Summary

- On April 2nd Co-Chairs Dorly Jean-Louis, Krystle Ferdinand as well as Staff Liaison Luisa Restrepo-Alvarez attended
 the Black Screen Office (BSO) Inaugural Symposium. The networking event focused on storytelling and the impact
 and influence of Black culture globally. The event featured a performance by Jully Black, panel discussions,
 interactive sessions, breakout rooms and an interview with keynote speaker Sean Cohanm the President of Bell
 Media. Highlights of the event were shared with members on the committee's Instagram and Facebook stories.
- On April 9th the Co-Chairs held a Blue-Sky Meeting with ACTRA Staff Liaison Luisa Restrepo Alvarez. At the meeting they briefly discussed the BSO Symposium. It was noted that the event seemed to be unclear as to whom this symposium is actually for. It was a diverse crowd of attendees producers, writers, actors and creatives. It felt that their mission seemed self-serving, unclear and too broad. It was a well-intended presentation but not quite worth the cost advertised. What is their call to action? It begs the question of how a global platform can be reached. The team also discussed upcoming initiatives. Co-Chair Roy Urbanozo took on a volunteering assignment at the ACTRA Awards. Co-Chair Krystle Ferdinand will be absent and out of the country from April 26 to May 6th. Ms Ferdinand also decided the team should meet on a bi-weekly basis instead of monthly. Ms Alvarez Restrepo suggested that the Executive Liaison team should be notified, invited to attend and made aware of that option. A few declines were received by email. The Reelworld Demo Reel initiative is something the Committee is still discussing. Picture Day is still aimed for November. Another idea is to hold a 48-hour film challenge with multiple

collabs where the short films could be screened at the ACTRA Awards, as an incentive for participation. They have already identified that morale and faith in the Union is low. They are working towards changing that. Ms Ferdinand spearheaded the idea of conducting surveys to be delivered to the members. The first, which she is in charge of, is a list of initiatives for their committee members to rank the top three they would like them to move forward with this year. The second survey is being conducted by Ms Jean-Louis. The focus is on the IPA, an openended question format on whether there has been improvement on screen where diversity and inclusion are concerned, what needs to be addressed, what are areas that can be improved, on set, audition calls etc. The questionnaire also requested members to highlight any challenges they face and changes they would like to see implemented in the IPA to better support BIPOC and physically diverse performers. Mladden Obradovic with the Accent Discrimination Sub-Committee reached out to Roy Urbanozo to help with more social media attention on Instagram and Facebook for the sub-committee. Mr. Urbanozo offered to create a proposal to present to Council to continue to raise awareness on the sub-committee. Ms Alvarez Restrepo suggested that the sub-committee should put the work in themselves to increase participation and attendance. Mr. Urbanozo should not be "chairing them. They need to show up."

- On April 16th at 2 pm the committee held their 2nd member meeting of the year via zoom. In attendance: Co-Chairs, Ms Jean-Louis and Ms Ferdinand and Ms Alvarez Restrepo. In total they had 44 registrants, 23 attendees all 44 registrants vetted. Note that this is a higher number of vetted registrants than the March meeting. This indicates that there is a growing interest from members to participate and join the meetups. A few members in attendance represented either the Accent & Discrimination Sub-Committee and/or the Disability Alliance Sub-Committee. Both Co-Chairs in attendance, Krystle Ferdinand and Dorly Jean-Louis introduced themselves and led the members into a Table Introduction to break the ice and welcome new faces. The agenda proceeded with Gugun Deep Singh who gave an update on WTSIC. His team is wrapping the submissions from the Call for Readers. From the Breakout Rooms discussions two optional initiatives were raised: Orientation: for BIPOC and physically diverse members and go-sees: to be re-introduced to showcase the depth and breadth of our membership. For example, a member pointed out that in Toronto has a huge population of Latinos and Spanish-speaking individuals. It's absurd to hire Americans to fill those roles. We have the caliber of talent here at home. Important to note that on the issue of IPA negotiations failing a majority of the members at the meeting seem to be in favour of a strike position. Members also raised several concerns and issues regarding Al and how ethical issues surrounding it will be reflected in the new IPA.
- On April 17th Dorly Jean-Louis attended National Canada Film Day for a special feature presentation dedicated to the late Black Canadian filmmaker Charles Officer's. It was an impressive turnout. The tribute included a screening of his film *Akillas Escape* which was held at the Scotiabank Theatre. A discussion followed reflecting on his legacy and enduring impact on the film industry. Highlights of this event were shared on the committee's Instagram and Facebook stories.
- On April 23rd the Co-Chairs held a follow-up meeting from 12 pm to 1 pm. Co-Chair Dorly Jean-Louis was absent. The gist of the meeting was to establish a monthly rotating schedule of tasks each Co-Chair is responsible for; to avoid delegating, confusion and to settle equal work distribution within the group.
- On April 25th Ms Jean-Louis emailed the 2024 IPA Survey to the membership. She also created a Work and Initiatives Folder she shared with Co-Chairs Roy Urbanozo and Krystle Ferdinand to organize, file and keep track of important documents, agendas, reports etc. related to the D&I Committee.
- Their collaboration with WTSIC continues. Co-Chair Roy Urbanozo created beautiful graphics for the casting Call for Readers which were shared on Instagram and Facebook pages. Submission deadline for performers is Thursday May 23rd at 6:30 pm for prep and 7-8 pm for the virtual event on zoom.
